CONTINUOUS ENROLLMENT

FREQUENTLY ASKED QUESTIONS

What does continuous enrollment mean?

Continuous Enrollment is a term that indicates once a student is accepted at Westminster Christian Academy and begins school, they will be enrolled until they graduate, or until the parent and/or school provides notification of their intent to withdraw or transfer the student per the guidelines in the contract.

Do we still need to provide a pastoral reference form?

School families are required to regularly attend a Bible-believing church and provide the necessary form during the routinely scheduled process. If your church changes, please submit a pastoral reference form from your new church.

Do all families submit a Re-affirmation of Covenant form?

Yes. We are asking that all families submit this form yearly to confirm your commitment to a covenantal relationship with Westminster.

How does continuous enrollment work in place of re-enrollment?

Once the Continuous Enrollment Contract is on file for your family, you will not need to fill out online re-enrollment forms or sign further contracts for your student(s). Each school year, you will be notified of tuition and fees for the following year in January and the school will bill the enrollment fees on your Blackbaud Tuition Management account.

You will, of course, be reminded periodically throughout the school year to update your family's contact information and student medical information in our school information system. That information is necessary for emergencies and communication regarding your student.

How will enrollment fees be billed?

The school finance office will bill your enrollment fee in Blackbaud Tuition Management to be payable in March. This fee reserves a slot for your child.

What if I do not intend to have my child continue at Westminster?

We ask that you notify us by January 31 of your intent to discontinue your student's enrollment at Westminster. Preparing for our next school year begins with knowing next year's enrollment numbers and using those to plan for curriculum, hire and retain quality teachers and prepare our facilities for the anticipated student body. Notification by the end of January will remove financial responsibility for tuition and enrollment fees and your child will be considered withdrawn for the upcoming school year.

How will tuition and other expenses included in the yearly costs be billed?

We will bill tuition and yearly expenses as noted in Blackbaud Tuition Management. You have chosen your preference for billing in 12 monthly payments, two payments (with 1% discount on tuition alone) or one payment (with 3% discount on tuition alone). This preference is noted on your Continuous Enrollment Contract; however, your payment plan may be changed by emailing admissions@wca-hsv.org. Course fees are not posted in the tuition management system until after the drop/add period. Athletic fees are not posted until the athletic department receives a roster from the coach at the beginning of each season.

Can I still apply for Tuition Assistance?

Families may still apply for tuition assistance using the Blackbaud Financial Aid Management application. We encourage you to do so early as limited funds are available. Once the funds are allocated, we are unable to provide further tuition assistance. For more information, see our [Tuition Assistance Information Sheet](#).

What if we withdraw our student's enrollment for next school year by the end of January and then change our mind?

To be fair to all, if you change your mind after January 31 and wish for your child to return, you will need to re-apply and start the admissions process anew, without priority status for a slot, and with the commensurate fees applied for open or extended enrollment.
